

General Information

1. Customers approved for the program will receive a 40% discount on water and sewer usage charges.
 2. Discounts will not apply to waste disposal, water rights, late charges or other associated fees.
 3. Eligibility must be established annually. To maintain eligibility, customer must sign a new application on or before the anniversary date of approval of the initial application.
 4. If a customer becomes ineligible for the discount, the Finance Department must be notified as soon as possible, but no later than 30 days from the date of ineligibility.
 5. Falsifying information or failing to notify a change in eligibility status may lead to:
 - Termination of water service
 - Recovery of past discount
 - Civil and or criminal sanctions

Eligibility Requirement

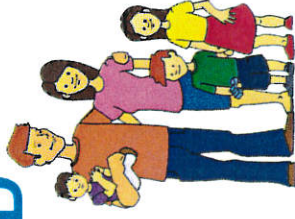
To be eligible for the discount, applicants must have an active City of Winslow water and sewer account for their residence in their name (or spouse's name) and meet the following requirements:

- Applicant must complete and submit the enclosed application, also available at the City's website.
- Total household income must be less than 100% of the current U.S. Bureau of Census federal poverty level for a **two-person household**.
- Applicant must provide proof of current household income with one of the following for all household members over 18:
 - Most recent Federal tax return
 - W-2 forms
 - DES letter from Child Support
 - Copy of most current three months bank statements
 - Benefit letter from Social Security
 - Pension Award statement, or
 - Any other documents deemed satisfactory by the City to prove income.
- Water discount applies to Tier I up to 15,000 gallons of usage.
- Water and sewer discount shall be applicable to one owner-occupied residential property.

Please Note:

The federal poverty guidelines are typically updated at the end of January each year.

LOW INCOME WATER AND SEWER DISCOUNT PROGRAM



A 40% discount is available on water and sewer consumption charges for qualifying low-income customers. Income requirements are based on current federal poverty standards.
